

## CONTEST RULES – Football Fever

### ARTICLE 1 – ORGANIZATION

TRANSATEL SAS (hereinafter referred to as the “organizing company”), registered with the Trade and Companies Register under number 432 786 432, with its registered office located at 1, Passerelle des Reflets, 92400 Courbevoie, France, organizes an automatic prize draw contest entitled “Football Fever” from May 28, 2026 to July 19, 2026 inclusive.

### ARTICLE 2 – CONDITIONS OF PARTICIPATION

The contest is open to any individual who meets the following conditions:

- Has purchased a “Football Fever” plan during the contest period
- Has an Ubigi customer account with a valid email address
- Is over 18 years old

Employees of the organizing company and their families are excluded.

Participation in the contest is conditional upon the purchase of a plan, with no additional cost related to the participation itself.

### ARTICLE 3 – TERMS OF PARTICIPATION

Participation in the contest is automatic. Any person meeting the conditions defined in Article 2 is automatically entered into the prize draw following their purchase.

Only one entry is counted per eligible purchase.

### ARTICLE 4 – SELECTION OF WINNERS

Winners will be selected by a random draw via the website “<https://www.tirage-au-sort.net/>” from among all eligible participants at the end of the contest, after July 19, 2026. Participants’ personal data will be anonymized during the process. The draw is conducted randomly using a method that ensures impartial selection.

Winners will be contacted by email at the address associated with their account.

Any winner who does not respond within 5 working days will be deemed to have forfeited their prize, which may then be awarded to another participant.

Winners may also freely choose to decline their prize.

### ARTICLE 5 – PRIZES

The contest includes the following prizes:

- 10 national team football jerseys valued between €100 and €110 each (depending on brand and model).

Each winner will receive one jersey. Therefore, there will be 10 winners.

Prizes are neither exchangeable nor refundable.

In the event of force majeure, the organizing company reserves the right to replace a prize with another of equivalent value.

The organizing company reserves the right to verify the identity and information provided by participants.

Any fraud or failure to comply with these rules will result in the participant's exclusion.
